Subject to the following terms and conditions made by Northpark Equestrian  
Limited

**FEES:**

- The Service Fee is NZ\$2350.00 plus GST.
- This fee includes a non-refundable Booking Fee of NZ\$300.00 plus GST payable on signing of this contract. This ensures your place in Doringcourt's service book which may be limited
- The balance of the Service Fee NZ\$2050.00 plus GST is payable BEFORE the first shipment of semen is sent by North Park Equestrian Ltd to the Mare Owner/Breeder/Leasee Semen will not be sent unless payment has been received
- The receipt of the Service Fee confirms the mare's reservation to breed to "Doringcourt" in the current breeding season that extends from 1<sup>st</sup> September 2011 to 1<sup>st</sup> March 2012
- Courier fee's are dependant on the physical address for the semen to be sent to and will be billed out after each shipment of semen to the Mare Owner/Breeder/Leasee  
Semen transported on public holidays may incur additional freight charges
- Stallion services are by Artificial Insemination (AI) only
- We require the semen shipper to be returned back to North Park Equestrian Limited within 48 hours, at your cost
- Frozen Semen is available which will incur extra cost, please make separate enquiries to North Park Equestrian Ltd regarding frozen semen

**LIVE FOAL RETURN SERVICE**

- . **If the mare fails to get in foal or a live foal does not eventuate, she is eligible for a return service the following season, but will incur another booking fee (NZ\$200.00 plus GST) and any associated collection (NZ\$220.00 + GST) and courier fees. It is accepted that North Park Equestrian Ltd may require a negative Uterine Culture (swab) Certificate prior to the Mares return**
- . **If the mare tests positive for pregnancy but becomes barren during gestation, she will be eligible for a return service. A veterinary certificate confirming this must be sent to North Park Equestrian Ltd within 10 days of the Mare becoming barren**
- . **If the mare produced a live foal that dies within 24 hours of birth, she will be eligible for a return service. A veterinary certificate must be sent to North Park Equestrian Ltd within 10 days of the foal's death. It MUST state that the mare was properly cared for and attended at foaling**
- . **If the mare becomes unbreedable for any reason, the Mare Owner may nominate a second mare for breeding. Breeding of that second Mare can only take place with the consent of North Park Equestrian Ltd, such consent to be given in North Park Equestrian's sole and absolute discretion**
- . **In all circumstances where a return service is accepted, the Mare Owner/Breeder/Leasee will be liable for another booking fee (NZ\$200.00 plus GST) and any associated collection (NZ\$220.00 + GST), courier and vet fees**
- . **If the mare changes ownership before a live foal eventuates, North Park Equestrian Ltd MUST be notified in writing within 10 days of the sale with new owners details**
- . **The live foal guarantee does not apply:**
  - . **If the mare is not foaled under approved supervision at a recognised stud or veterinary establishment, OR under mare owners supervision at the discretion of North Park Equestrian Ltd**
- . **North Park Equestrian Ltd is not liable for lost, delayed or damaged semen due to circumstances beyond their control**

**REFUND OF FEES:**

- . **The Mare Owner/Breeder/Leasee is entitled to a refund of the Service Fee paid, less the booking fee and collection fee and any outstanding courier and vet fees, if Doringcourt dies or becomes unfit for breeding prior to the Mare conceiving in the current breeding season**

**REQUIREMENTS:**

- . Orders for semen must be placed with North Park Equestrian Ltd 48 hours before the semen is required
- . All Veterinary costs are to be paid by the Mare Owner
- . A Certificate of Service will be issued for this Contract, which will pertain to the mare described in this Contract. It will be provided once the mare has tested 42 days in foal and all outstanding invoices have been paid to North Park Equestrian Ltd by the Mare Owner/Breeder/Leasee
- . North Park Equestrian Ltd reserves the right to refuse any mare
